1. Applicant Information
  - 1.1 Applicant's reference: File reference within the applicant's file referencing system for record identification details
  - 1.2 Aircraft owner / operating organization Military Air Operator (RNoAF) or CAMO responsible for the aircraft in question.
  - 1.3 Designated contact person for enquiries about the application
  - 1.4 Classification per EMAR 21.A.173, based on Type Certification status
2. Manufacturer and manufacturer's designation of aircraft, e.g. *Boeing P-8A*
3. Aircraft / Engine / Propeller / Rotor / APU details
  - 3.1 Registration mark (as entered in the Norwegian Military Aircraft Register)
  - 3.2 Manufacturer of the product; e.g. *Boeing Defense Systems, CFM International etc*
  - 3.3 Type & Model of the product; e.g. *CFM56-7B27AE*
  - 3.4 Serial number of the product
  - 3.5 Hours & Cycles
4. Type design and other information
  - 4.1 Provide details of Military Type Certificate or Military Restricted Type Certificate and associated Type Certificate Data Sheets (applicable documents to be attached)

5. Declaration by the Accountable Manager of the Operator, or an authorized designee (e.g. Continuing Airworthiness Manager CAM). The signature implicates that the guidelines have been read and understood, the application form has been completed in full, including necessary 25a-A/25a-B sheets, with true and correct, and that the terms and conditions of the process have been accepted.

### **Submitting the form.**

The completed Form 25a, together with referenced documentation is submitted to MAA-NOR through DocuLive, or as directed by MAA-NOR on a case-by-case basis.
